What is trafficking in persons?

Trafficking in persons is the recruitment, harbouring and controlling of a person for the purpose of exploitation. Labour trafficking is a form of trafficking in persons. Common elements of trafficking include:

- Passport and work permit withheld
- False contracts, switched contracts
- Lack of pay or severely low pay
- Excessive working hours
- Change of promised job duties
- Physical or sexual abuse
- Being kept in the house, unable to leave
- Phone calls, letters, visits monitored
- Threats of deportation
- Verbal and emotional abuse
